**Terms and Conditions**

1. These terms and conditions are for all entrants who enter the ‘Red Envelope Giveaway’ Centre (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The “Promoter” is Dexus Funds Management Limited (ABN: 24 060 920 783) as Trustee for Dexus CPA Trust and Victoria Square QV Investments Pty Limited. The address is QV, Cnr Lonsdale and Swanston Streets, Melbourne, VIC 3000

**ELIGIBILITY**

3. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over.
4. The following are ineligible: (i) employees of the Promoter, Dexus or any of the tenants or retailers in the Participating Centre/s or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

**HOW TO ENTER**

7. To enter this Promotion, eligible individuals must, during the Promotion Period, simply:
  - Visit the Lunar New Year ‘Dancing Bunnies’ installation in QV Square.
  - Present your receipt/s of a minimum \$20 spend in a single day from any QV stores, excluding Woolworths, Big W, Domayne, Harvey Norman, Officeworks, BWS, Dan Murphy’s and Wilson’s Car Park. \$20 spend can be accumulative transactions across multiple QV stores. Date of receipt/s must be dated the same day as prize redemption.
  - Scan the QR code and sign up to the QV E-List.
8. It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoters database and to be used in accordance with the purposes set out in these Terms and Conditions.
